NEW HEALTH & SAFETY ENHANCEMENTS

PREPARING FOR YOUR VISIT

We are committed to ensuring your safety and health when visiting Salon Addison Davis and Heartwood Spa, ask that you partner with us on simple steps before and during your visit. Here is how you can prepare for a relaxing and safe experience:

GUEST EXPERIENCE

- Reservations for all services at both Salon and Spa are required.
- Thank you for wearing a mask. We will assume if you do not have a mask on its because of a medical condition.
- To ensure social distancing:
 - Partitions are in place at reception desk.
 - Appointments will be scheduled to manage appropriate capacity.
 - Contactless check out will be available with a credit on file, given before your appointment.
- Clients will be asked to sign a COVID-19 screening form upon arrival.
- If you are sick, experiencing COVID-19 symptoms, or exposed to someone who has tested positive for COVID-19 within 14 days of your scheduled spa treatment(s), please contact us and reschedule your service(s).

TREATMENTS AND SERVICES

- All treatments and services will be available, except for makeup services.
- Guests will be welcome to remove their facial covering during a facial and when face down during a massage.

EMPLOYEE PRECAUTIONS

- Team members will be thoroughly trained on the recommended precautionary steps from the Centers for Disease Control and Prevention and the Pennsylvania Department of Health to inhibit the spread of germs.
- All team members will be wearing face coverings and gloves where appropriate.
- Hand sanitation stations available throughout the salon and spa
- Team members will be required to have their temperature took before starting work.
- Stations will be properly disinfected for each client.
- Regular clean producing will be increased throughout the day
- Where possible, workspaces will be redesigned to enforce social distancing.
